CONTEST RULES AND REGULATIONS

The Contest begins on or about 9:00 AM (ET) June 17, 2019 and ends at 11:59:59 PM (ET) on August 17, 2019 the "Contest Closing Date" (hereinafter referred to as the "Contest Period").
